

# Call for Poster and Platform Abstracts

APTA Pediatrics Annual Conference  
November 19-21, 2021

Deadline for submission is June 30, 2021, 11:59 pm (Eastern Time)

This *Call for Abstracts* is for poster presentations at the **2021 APTA Pediatrics Annual Conference**. A fee of **\$25** is associated with submission of each abstract; this fee defrays a portion of the cost of the review process. If an abstract is accepted for presentation as a poster or platform, the person presenting **must** be registered for the APTA Pediatrics Annual Conference. Registration fees are not waived for presentation of a poster or platform. The conference will either be fully virtual or hybrid (part virtual and part in-person) this year - a decision will be made soon. The committee will communicate details about the format of presenting in the coming months. Submissions are welcome starting on **May 15<sup>th</sup>, 2021**.

Abstracts are intended to represent research or non-commercial content related to pediatric clinical practice. Advertisements are not acceptable. The abstract must be original work that has not been published elsewhere. ***Abstracts may not be submitted to multiple APTA meetings. For example, the same abstract may NOT be submitted to both CSM and APTA Pediatrics Annual Conference. If an abstract has already been published, it may NOT be submitted.*** You do not need to be an Academy of Pediatric Physical Therapy member to submit. Accepted abstracts will be published electronically in *Pediatric Physical Therapy* without editing. For this reason, abstracts must strictly adhere to the following guidelines.

- Maximum number of characters: 3,125. This includes spaces, but not authors or institutions.
- For authors and institutions, follow this example:  
AUTHORS/INSTITUTIONS: Davis DC, Department of Physical Therapy, Big University, Anytown, AK; Smith RZ, Children's Hospital, Anytown, AK.
- For titles, follow this example (capitalize all letters in the title):  
TITLE: PARENTS' PERCEPTIONS OF INTENSIVE PHYSICAL THERAPY FOR CHILDREN WITH CEREBRAL PALSY.
- It is expected that the submitting author will receive permissions from all authors and author order will be final upon submission.
- Communication regarding posters and platforms that are accepted or not accepted is generated through the submission site only. Please provide the email address of the presenting author on the poster submission.
- Use people-first and non-biasing language.
- Scrutinize spelling and grammar.

All abstracts must be submitted online, one at a time. The online application will prompt you to select a type of abstract and to insert the information in the fields listed in the table below for your type of work.

Types of abstracts with associated sections are described here and listed in the table below.

- A **Research Report** is hypothesis driven or descriptive research that includes multiple subjects and objective and/or subjective data.
- A **Case Study or Case Series Report** describes a unique intervention or assessment on one or a few subjects. Data is typically descriptive.
- A **Special Interest Report** describes a unique program or aspect of pediatric physical therapy that is of clinical interest. Data may or may not be available.
- A **Theory Report** describes a unique theory to guide practice. The abstract will describe the proposed theory, which has not yet been tested.

Additionally, given current restrictions on human participant research, the committee recognizes that many projects may have been paused for public health safety. Therefore, **“work-in- progress”** proposals can also be submitted under the most appropriate type of abstract listed in the table below. For a “work-in-progress” proposal, the submitter is encouraged to reflect on what they hope to see in their results and discussion sections.
